## AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RUSHVILLE, INDIANA REGARDING FLOOD HAZARD AREAS

WHEREAS, THE City Council of the City of Rushville has determined it necessary to amend the Flood Hazard Areas Ordinance 2014-20 as follows:

Article 4. Administration.

Section A. Designation of Administrator.

The City Council of the City of Rushville hereby appoints the Planning and Zoning Administrator, to administer and implement the provision of this ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RUSHVILLE that Ordinance of the City of Rushville is amended as follows:

Article 4. Administration.

Section A. Designation of Administrator.

The City Council of the City of Rushville hereby appoints the Planning and Zoning Administrator, to administer and implement the provision of this ordinance and is herein referred to as the Floodplain Administrator.

## **SEVERABILITY OF PROVISIONS:**

If any provision of this Ordinance is declared invalid, by a court of competent jurisdiction, for any reason, the remaining provisions shall not be affected, if such remaining provisions can, without the invalid provision or provisions, be given their original intended effect in adopting this Ordinance. To this end, the provisions of this are severable.

## REPEAL OF PREVUOUS ORDINANCES:

All other part or sections of the previous Ordinance regarding Flood Hazard Areas that are not in conflict shall remain in full force and effect.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF RUSHVILLE, INDIANA, this Ordinance will be in full force and affect from and after its passage and signature by the City Council of the City of Rushville, Indiana, as provided by law, and upon any further requirements under Indiana law.
